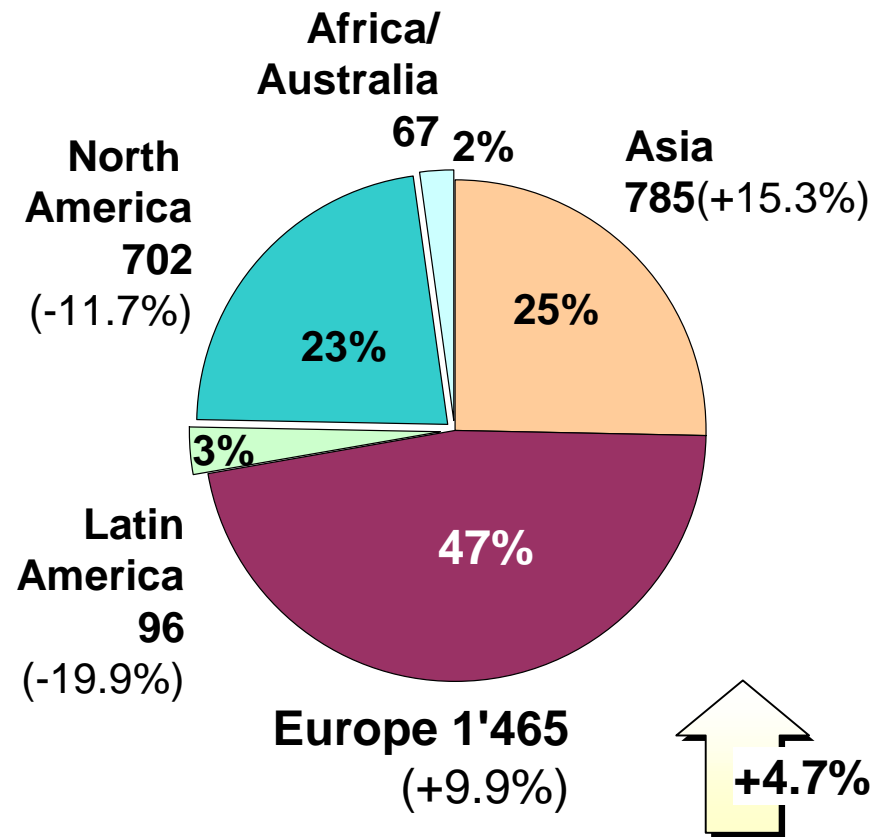

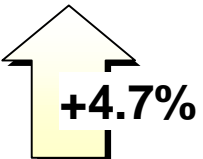
Sales by Geographical Region



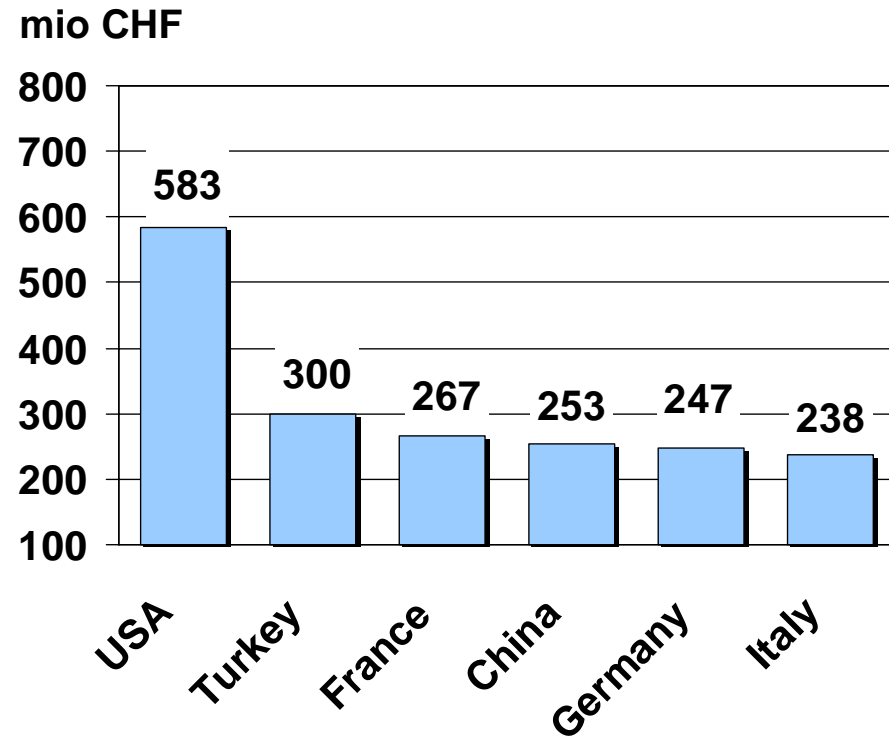

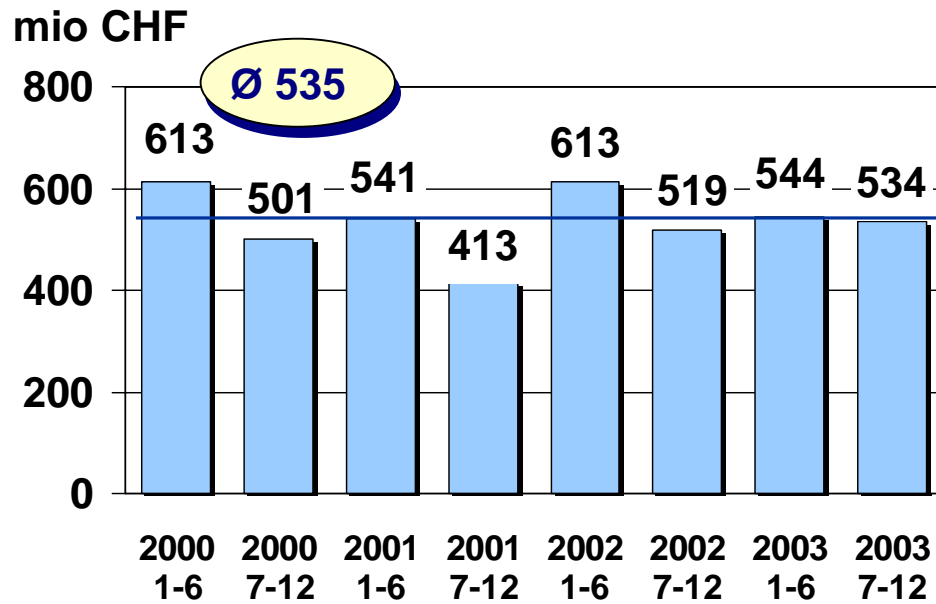

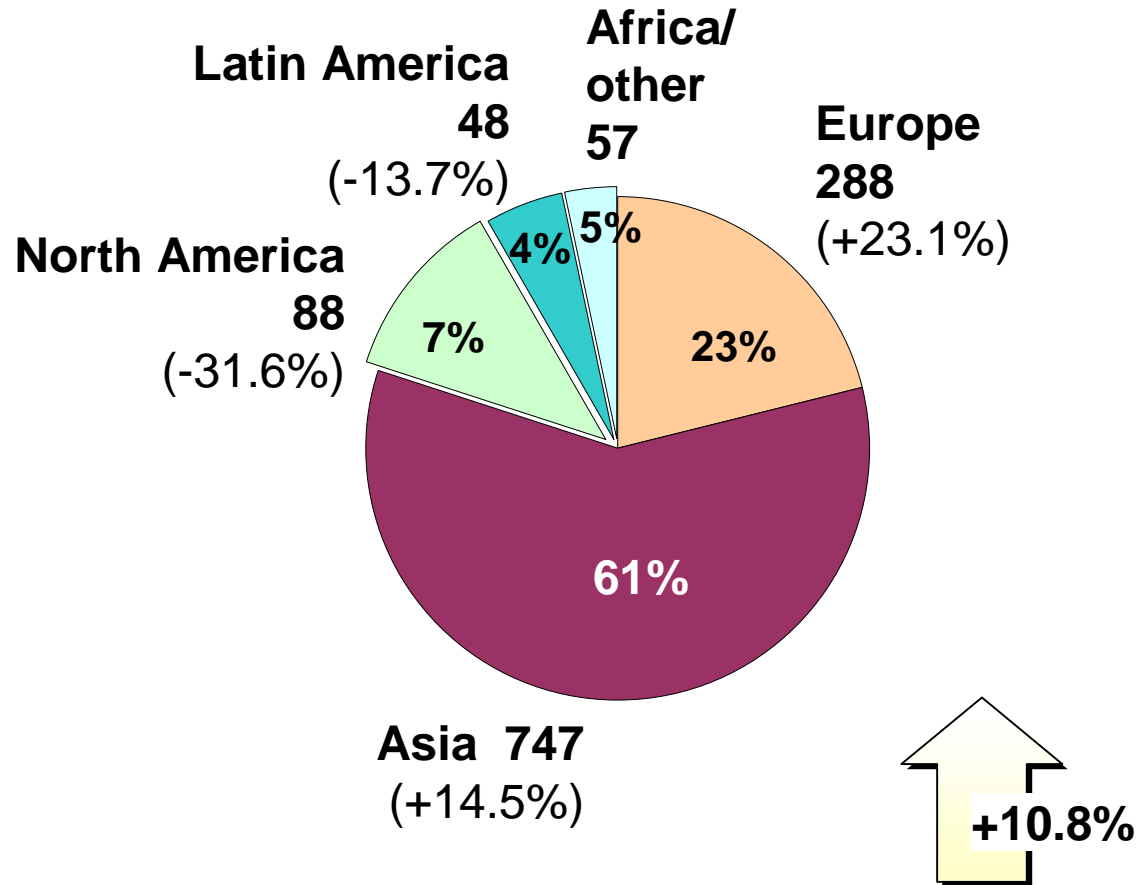

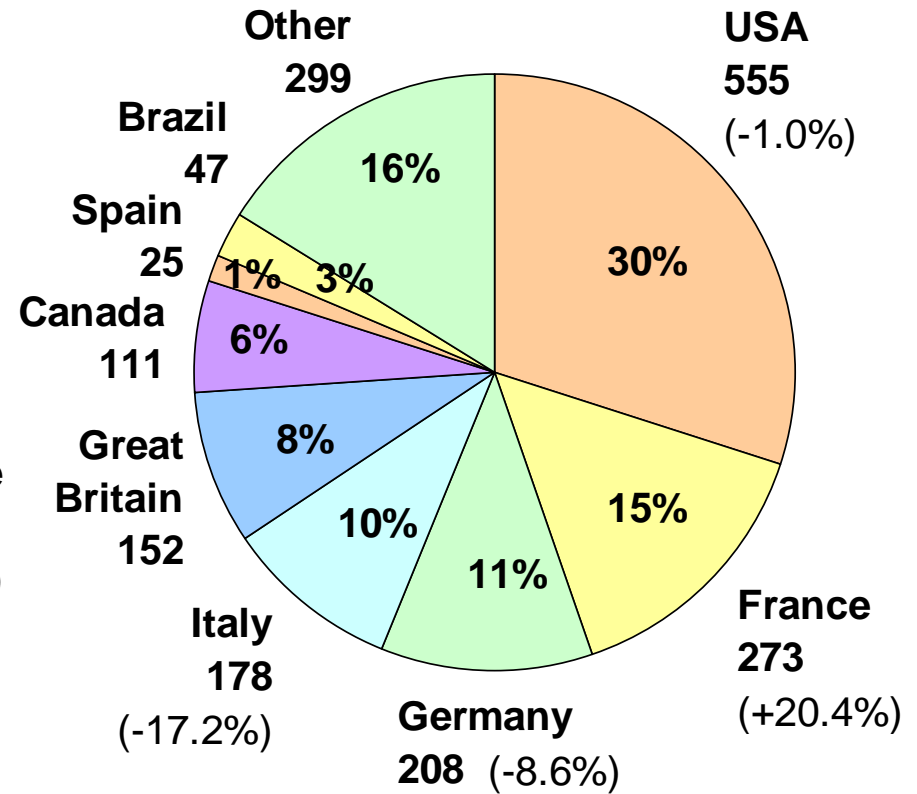

Main Sales Growth in China and Turkey



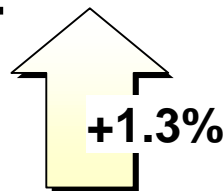

Sales Growth in a Challenging Market Environment

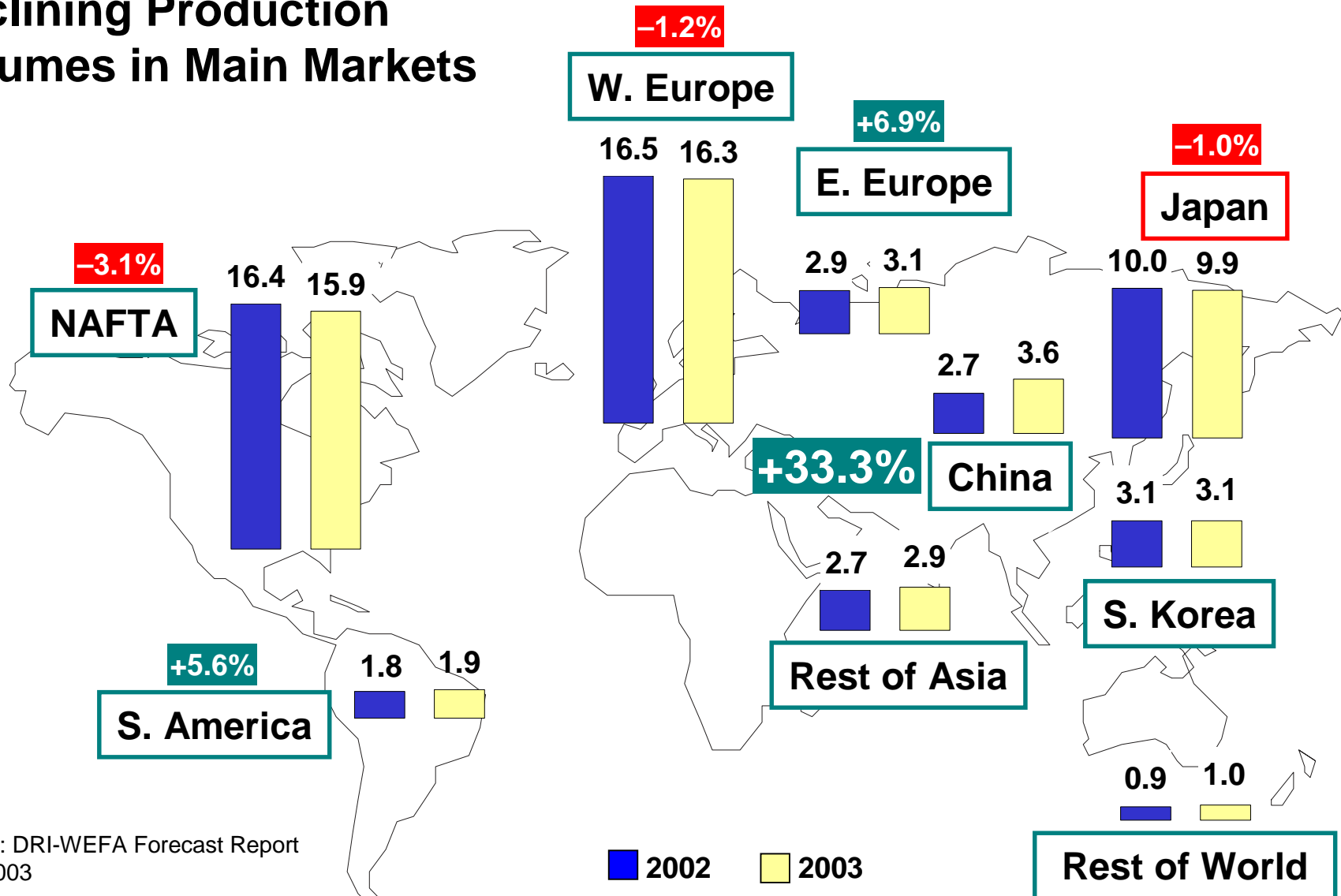

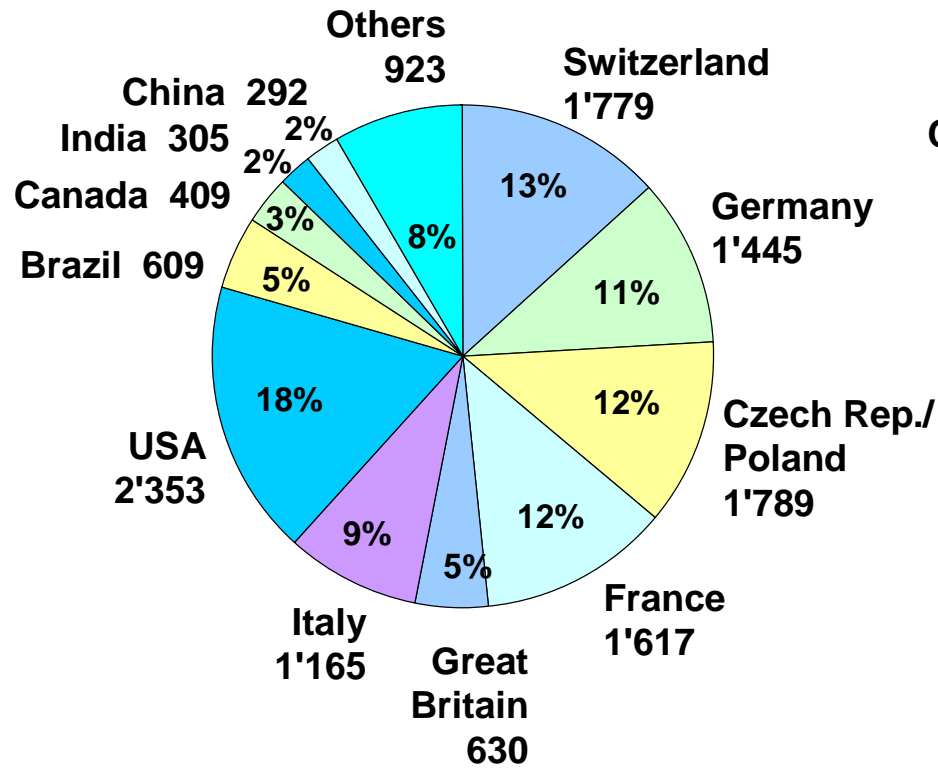


Declining Production Volumes in Main Markets

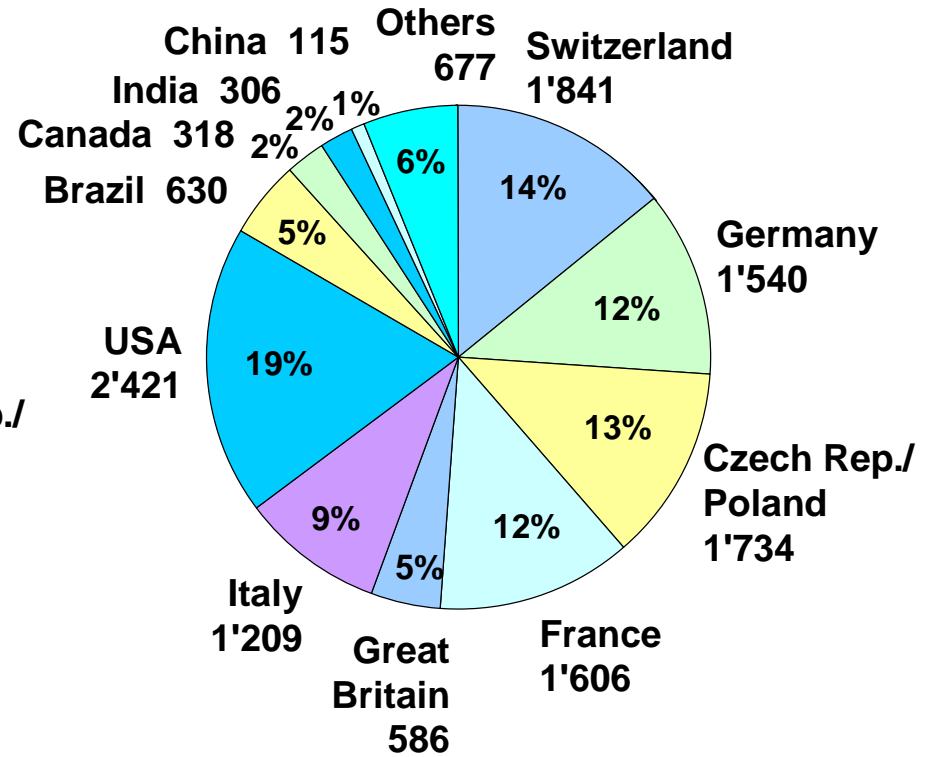

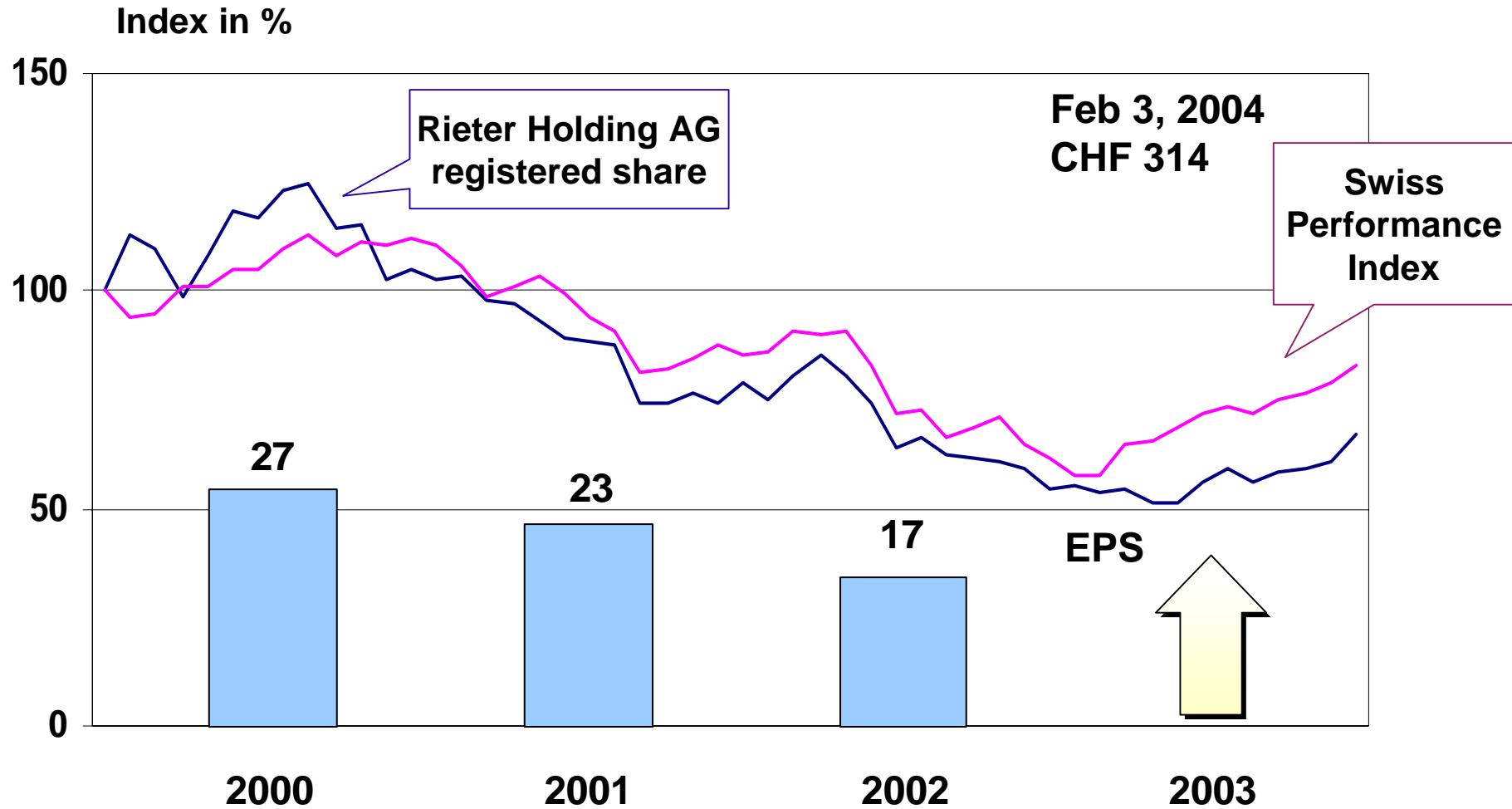
